

HOW WE CAN PUT A PIECP PARTNERSHIP TO WORK FOR YOU

CHOOSE FROM THREE WORK MANAGEMENT STRUCTURES

Customer Model KCI handles all production and simply sells you the finished goods

Manpower Model

You oversee production and pay KCI a fee to manage labor and overhead

Employer Model You run the project and hire, fire, train and pay inmate workers, using KCI's space and labor pool

WHAT YOU SHOULD KNOW

Inmates must be paid commensurate with prevailing wage for similar work.

You must certify that : 1) you will not displace workers in the private sector; 2) there's not already a labor surplus in the relevant trade, and 3) you will not impair existing contracts.

KCI must notify local industry and organized labor, comply with environmental laws and obtain written assurances from inmates that their participation is voluntary.

Projects must be approved by the U.S. Bureau of Justice Assistance

Thanks to justice reforms signed into law by Gov. Matt Bevin in 2017, our program is now certified by the federal government, allowing products made with inmate labor to be sold outside Kentucky for the first time. This means we can advance your business like never before.
